Terms of Use

Please read this agreement carefully before booking your Babytastic classes. By sending back the signed booking form, you agree to be bound by this agreement. The information and services you will receive in your classes are provided by Babytastic, subject to your agreement to the terms and conditions below.

Use of Information

The information contained in your classes and handouts is intended for general guidance only and is not intended nor should it be used as a substitute for medical or other professional advice. Babytastic disclaims all liability for errors, omissions, incomplete or misleading content.

Always seek the advice of your doctor or other qualified health care professional with any questions you may have regarding your specific situation and prior to starting any new treatment. Nothing contained in the classes are intended to be used for medical diagnosis or treatment. The information and services are provided with the understanding that Babytastic are not engaged in rendering legal, medical, counseling or other professional services or advice.

Babytastic assumes no responsibility for any consequence relating directly or indirectly to any action or inaction you take based on the information or material you receive in your classes.

Service

The course consists of 4 evening sessions for couples held at our selected venue and 1 ladies only session which is generally held at an eating establishment. Indemnification

You agree to indemnify, defend and hold harmless Babytastic from any liability, loss, claim and expense (including reasonable legal fees) directly or indirectly related to your breach of this agreement.

Proprietary rights

The intellectual property in all materials received in your classes are owned by Babytastic and without limitation are subject to the copyright of Babytastic and may be photocopied a limited number of times only for your personal non-commercial use. Without the prior written permission of Babytastic, you may not distribute, transfer or store in a machine readable form or transmit (including by internet and email) any material received in your classes or otherwise supplied by Babytastic to you in whole or in part.

Consequential Loss

If Babytastic has to cancel a course for any reason, you will be entitled to a full refund but (subject as foresaid) we will not be liable for any consequential loss.

Notices

Babytastic reserves the right to change the venue at any stage due to circumstances beyond our control. In the event of this situation, Babytastic will contact you as soon as possible to notify you of these changes. Any changes to these terms and conditions will be communicated to you by letter.

Variation

No addition to or variation of these conditions will bind the business, unless it is specifically agreed in writing and signed by a director or company secretary. No agent or person employed by or under contract with Babytastic has the authority to alter or vary these conditions in any way.

Payment

Cost of the course is £160. Payment is required in full to book your place on the course. See below for our refund policy. However, if you do change your mind within 7 days of Babytastic receiving your cheque, you are entitled to a full refund.

Refund Policy

If you are unable to attend the course through medical reasons or early arrival of the baby BEFORE the course starts we will refund the full course fee less a 20% administrative charge. If you only attend a proportion of the course due to medical reasons or early arrival of the baby, we will refund the remaining proportion of the course fee less a 20% administrative charge. Babytastic does reserve the right to ask for a medical certificate or other supporting evidence.

Cancellations for non-medical reasons will be eligible for the following refunds: More than 2 months in advance of the start of the course: full refund less a 20% administrative charge. Between 1 and 2 months in advance of the start of the course: 75% less a 20% administrative charge. Between 2 weeks and 1 month in advance of the start of the course: 25% less a 20% administrative charge. Refund less than 2 weeks before start of course: No refund.

Force Majeure

If Babytastic is prevented from or delayed in providing any of the services under this agreement due to circumstances beyond its reasonable control including without limitation, acts of God, governmental actions, war, national emergency, acts of terrorism, riot, civil commotion, fire, explosion, flood, epidemic or breakdown or non availability of equipment or premises. Babytastic reserves the right to defer the date for delivery of any services or to cancel this contract.

Miscellaneous

Babytastic's failure to insist upon strict enforcement of any provision of this agreement shall not be construed as a waiver of any provision or right.

This agreement will be governed by and construed and interpreted in accordance with the laws of England and the parties hereby submit to the non-exclusive jurisdiction of the English Courts.
